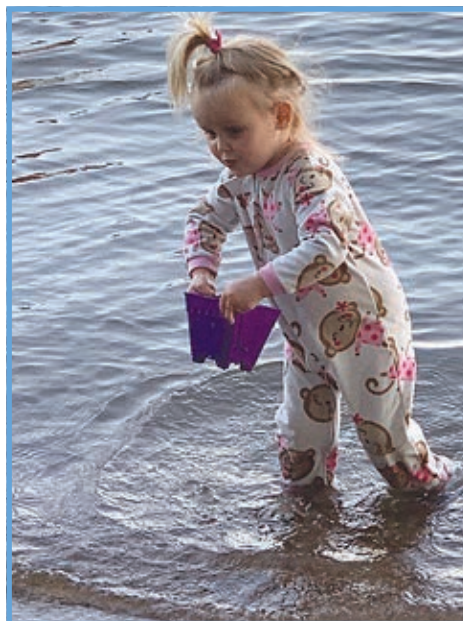

if we could help save this property for future generations. The property is currently used for walking, cross country skiing, bird and other wildlife watching. This project fits very well with our purpose as defined in our articles of incorporation. After many hours of discussion with the county and various government organizations, it was determined the Waste Water Management District would own and conserve the property. An agreement has been made with West Central Initiatives of Fergus Falls who will spearhead the fund drive. The lake association will assist them in their fundraising efforts and support the project. No current OTLPOA or Foundation funds will be used for this project. This is a separate project and all donations will be made to West Central Initiatives who will hold the money until the purchase date. We have a goal of \$90,000.00. The Foundation also provided swimming lessons at the park this year. The lessons are put on by the Red Cross and all participants who complete the class are refunded the cost of the lessons by the Foundation. This is a great opportunity to get your kids/grandkids into a lake swimming environment.

We have been informed the public access on Deer Lake will be closed from Sept. 9 thru October.

The board has also been working

with the residents of Round Lake. Round had a serious winter kill last winter. They are working with the DNR and fisheries to monitor and restock the lake. The association voted to approve matching funding for restocking costs over a two-year period. We are excited about this project and hopeful the restocking efforts succeed in replenishing the lakes fish.

I would like to personally thank our water testers for all their efforts. This group goes out once a month and samples water, does clarity checks, and has the waters tested at a lab in Detroit Lakes. This is a great group most people probably aren't aware of their efforts. This is my first year as a water tester and I now have a better understanding of the effort involved in taking samples. Thanks again to all who help!

As I write this letter, the sun is shining, lake is beautiful, and grandkids are waiting for Papa! Enough said. Have a great remaining summer and get out and enjoy the wonderful lakes we have.

## First Annual Long Lake Carp Fishing Derby

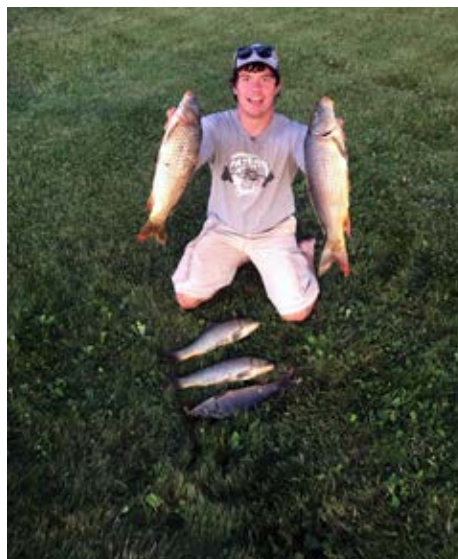

## Water Pollution

Everyone knows that trash is no good for lakes and rivers, but many people unwittingly contribute to water pollution because they do not understand that "natural" debris—leaves, grass clippings, fertilizer, road salt, and pet waste—becomes pollution when it hits the water.

When these natural pollutants break down, they become food for algae, causing it to grow out of control. Here's how it works...

- Organic stuff like leaves and grass wash down into the water.
- Algae and weeds are fed by all this organic matter.
- Water gets green and soupy.
- Less sunlight gets through the water so bottom plants can't grow. Fish and wildlife lose habitat.

When a lot of algae die, they create a dead zone.

Don't feed the algae. Help keep our waters clean by doing your part...

- Pick up after your pet. Dog poop carries harmful bacteria.
- Leaves, grass and dirt feed algae and turn lakes and rivers green. Keep them off streets and sidewalks.
- Trash clogs drains and pipes, causing flooding. Put it in a garbage bin.
- Remember when winter comes, salt is almost impossible to remove from waterways. Just one teaspoon pollutes five gallons of water forever. Use it sparingly. Sweep up and reuse extra. Use sand when temperatures fall below 15 degrees.

Chautauquas were held in the late 19th and early 20th century to bring education and culture throughout rural American until about the mid-20s. The second annual Aqua Chautauqua in Minnesota hopes to recapture some of that spirit of discovery in Detroit Lakes Aug. 15 at Dunton Locks County Park

from 5-8pm.

The free outdoor learning festival has more than 20 interactive learning stations, including:

- Create your own water art project
- Sample drinking water from around the state at the Water Bar
- See the aquatic robotics demonstration
- Explore a land use simulator
- Learn how aquatic insects can serve as clean water indicators
- Many more.

*The event is hosted by the University of Minnesota Extension service along with local and state agencies and organizations involved with helping Minnesota residents learn about and protect our much-valued lakes and streams. This year's event has a special focus on the Otter Tail River Watershed. In addition to learning, you can sign up to win a kayak.*

### CALL TO ORDER/ROLL CALL

**Approval of Agenda** – unanimously approved as distributed

**Approval of Minutes** – unanimously approved as distributed

**Approval of Bills** – Approved unanimously as distributed

**Presidents Report** – No report due to Round Lake residents presenting information on Lake Freeze out.

Round Lake residents reported their lake froze out over the winter, they had to restock using private funds due to lake not having a public access. They are wanting donation from OTLPOA. This will be discussed at July meeting.

### Committee Reports

**Membership** – Snyder reported we are at 1066 members. We have approx. 1,000 email addresses. Discussed ways to use and get more. Wentz reported 2nd mailing sent out, getting some response back from people that they had already paid. Discussed ways to do better mailing.

**Auditing/Finance** – Need budget for next year.

**DNR/GOV'T** – Fishing opener 2020 discussed, Steeves reported that Howard Fullhart will be speaking at annual meeting. Wright County discussed, Otter Tail County AIS board is asking DNR commissioner to attend meeting in July to discuss. 57 boats used decon unit at Pelican Bay access along with 6 boats that just wanted to clean their boats.

**Water Testing/COLA** – Otter Tail reading is 20 ft. and Blanche at 13 ft., Long Lake at 1ft. Long Lake low reading due to high phosphorus levels. Long Lake phosphorus levels are down from 52 to 38.

**Communications** – Website is

updated for secure credit card payments. New contact is John Carlson.

**Worm** – Worm spraying was very successful. Over 50% payment from mailing. Discussed ways to improve mailing, finding out who is paying.

**Foundation** – Discussed swimming lessons, they will be held last week of July to 1st of August. Location of next year's lessons may change due to shallow water and bugs at Amor location. Buoys are all out on Otter Tail Lake. Looking for new board member. Old buoys for sale, will put ad in LSN.

**Rearing Pond** – Bope reported had a meeting with WCI and Water Management Board. Water Management board will not allow any improvements. No new signage will be allowed. Will have a full page ad in LSN and in Presidents corner. Committee will meet June 28th 1PM to discuss plan going forward. Once memorandum of understanding is signed payments can be made.

**Social** – Plan for Annual meeting June 29th. Doughnuts and rolls from Ottertail Bakery, juice, coffee water will be provided. Notices of meeting were placed in Battle Lake Review and Midweek. Speakers speak for 10 – 15 minutes. Board should be there by 7:30AM.

**Old business** – Donation to U of M AIS foundation. This will be on July meeting agenda. Bernie discussed plans for fishing opener 2020, they would like it to be county wide to promote Otter Tail County. They would like 500 to 600 volunteers. Bernie asked for back up to attend meetings in Jan./Feb. next year as he may be gone.

**New Business** – Lynn discussed Long Lake, they will be having a 1st annual carp tournament in July. A meeting notice of an RV park on Long Lake, will need more information.

Meeting was adjourned at 9:00pm. Next meeting is July 25th at 7:00pm.

There's a newspaper article from 1957 framed on the wall of my grandparents' cabin. My grandfather, having just graduated from high school at the time, and one of his friends swam across the 3.5 mile width of Otter Tail Lake. After hearing the story as a youngster (and plenty of times from my grandmother through past summers), I decided that my time to tackle the swim had come. I wouldn't be completing it alone, however. My father had also decided to tag along, aiming to make the event a generational trifecta. Thursday, July 11, 2019 was the date; a sunny morning with a light south wind. I set out first, with my dad, brother, and his fiancé following alongside in the pontoon. I was lucky enough to have a water-proof iPod Shuffle along as well, and quite the playlist to help ease the boredom. **Presidents Report** – Pres. Simdorn discussed music on the lake. He had received a call wondering if OTLPOA sponsored the Tunes on Toons, Simdorn informed him that we do not. They need approval from DNR and permits to do this.

**Worm** – Worm spraying costs were discussed, had good participation across the lakes in the association.

**Foundation** – Foundation has \$29,996.00 in the bank and \$30,378.00 in CD's. New board members were voted on by OTLPOA board, Jon Anderson and Lana Ouren were approved to join foundation board. Steve Mouritsen was approved to be the liaison to OTLPOA board. Discussed swimming lessons, 51 swimmers participating. (Even though we could according to our By Laws/Articles of Inc.) OTLPOA will not be the owner of the Rearing Pond (Even though we could according to our By Laws/Articles of Inc.). OTLPOA will act as a facilitator for fund raising efforts in order to assist the Water District Management to purchase the Rearing Pond property consistent with our purpose as stated in paragraph 3 of our Articles of Inc.

Motion was approved.

**Social** – Discussed Annual meeting attendance, how to improve will be discussed at later meetings.

**Old Business** – Donation to Round Lake for fish stocking was discussed. There are approx. 66 properties on Round Lake and approx. 25 – 26 have donated private money to this cause. After some discussion the board voted to approve a donation of \$2,250.00 this year with another \$2,250.00 next year.

Rob Bope made a motion to donate \$1,000.00 to U of M AIS foundation to support AIS research.

Motion approved.

Kemling gave an update on fishing opener 2020, they are looking at Phelps Mills for picnic to promote Otter Tail County. They are still wanting 500 to 600 volunteers. We will have an update on that after Sept. 11th meeting.

**New Business** – Election of officers – Scott Simdorn was re-elected President, Rob Bope was re-elected to Vice President, Pat Hunke was re-elected as treasurer, and Becky Kemling was elected as secretary.

Lynn gave an update on the Long Lake campground, they are proposing 53 unit lots and will have to adhere to the 1000 ft. set back. It will be discussed at the next Planning commission on Aug. 14th.

Fetters advised that the public access on Deer Lake will be closed from Sept. 9th thru October for improvement.

The September meeting will be held on Sept. 19th. Location to be determined.

## EOTSW/LLRPOA Long Lake Buffer Zone Project

On Friday, July 26, Paul Oxberry & Lynn Cave of the Long Lake/Riviera Property Owners Association (LLRPOA) met with Ben Underhill & Aimee Duchene (East Otter Tail Soil & Water) to begin the RFP (request for proposal) process for a grant to establish shoreline buffer zones on Long Lake. These wildflower buffer zones will help reduce phosphorus run off and contamination to Long Lake.

This grant will be a cost-sharing project with participating shoreline property owners, reimbursed 75% of the cost of their buffer zone installation.

## Quick Tips to Reduce Home Water Waste

Few people realize that the land of 10,000 lakes may soon face a water shortage. While surface water is abundant in our region, the majority of

the metro relies on groundwater. This out-of-sight natural resource is far from limitless. Groundwater isn't replenished as quickly as surface water, and our supply is already dwindling.

Become conscious of water waste is the first step to making a change. The EPA estimates that as much as 50% of the water used outdoors is wasted. A combination of evaporation, wind, and inefficient irrigation methods adds up to a massive loss of a precious resource.

Here's some quick tips to reduce home water waste

- Check an automated irrigation system for leaks and broken sprinkler heads at the start of each summer.
- Install a rain gauge in your yard. Grass needs no more than one inch of water per week, including rainfall.
- Set your mower blade to three inches tall to promote deeper grass roots. Deep root systems are more drought resistant.
- Install a smart irrigation controller — or simply run your irrigation system in manual mode only when needed.
- Establish native plants in your gardens that thrive with normal rainfall.

## 25-Year Anniversary Event Both Celebratory And Sober, Given Issues Facing Minnesota's Lakes & Rivers

For the 25th Anniversary Annual Meeting of Minnesota Lakes and Rivers Advocates (MLR), its Board decided to try something new: Have our annual meeting during the summer out in an area with a lot of lakes. It was a great idea, and a wonderful event.

Minnesota's lakes and rivers are in trouble. The Minnesota Pollution Control Agency has determined that 40% of our surface waters are impaired to the point where fishing and swimming are no longer recommended. There are impaired waters in every county of the state, and the current trends are towards more impairment, not less.

The solution to this is organizing the many lake home and cabin owners in the state, the lake associations, marina and resort owners, and local resource managers into a constituency that focuses on protecting un-impaired waters, and rehabilitating impaired water. I use the word "rehabilitating" rather than "restoring" because unlike prairies, forests and other terrestrial ecosystems, complete restoration of an impaired lake is very, very difficult, very slow, and very, very expensive.

Partnerships are the answer, and so the theme "Water Connects Us All" was born. Water does indeed connect us all. Most Minnesotans have a deep connection to a lake or river in Minnesota, and all MLR members recognize the need to be engaged and take specific actions to protect our lakes. Minnesota is the origin of three continental sized watersheds, the Mississippi River Basin that flows to Gulf of Mexico, The Red River Basin which flows north to Lake Winnipeg and ultimately the Arctic Circle, and the Great Lakes Basin which flows to the Atlantic.

The event was only possible with partnerships, including Cass County and the Leech Lake Band of Ojibwe, who donated generously to help keep expenses down. The food, service, and facilities at the Northern Lights Casino were exceptional. The Association of Cass County Lakes, ACCL, and President Linda Blake were key partners and responsible for much of the groundwork and planning. MN COLA was a co-host of the event with ACCL and MLR.

Almost 200 lake advocates attended. Twenty one different groups came to participate in the Water Connects Us All showcase, sharing the latest technology, programs, and information including a new Resort Ambassador's program, One Watershed One Plan participation and funding, new ways to increase lake association membership, opportunities to work with local schools to develop lake based science education, using weevils as a bio-control for Eurasian watermilfoil, new boat cleaning technology, and more. For a full list of all of the showcase participants, check the Water Connects Us All event program.

Special thanks to Hans Blix and the Weapons Inspectors for providing wonderful bluegrass music. Hans Blix and the Weapons Inspectors are not only wonderful musicians, but also natural resource managers in a variety of roles from non-profit, county and MN DNR. They truly are the water advocates' house band!

On Monday night, Cass County Administrator Josh Stevenson, and Leech Lake Band of Ojibwe President Robbie Budreau welcomed the group to Cass County. These two governments, over the course of many years, have developed a strong and trusting working relationship. The results are that their natural resources have benefited.

Attendees enjoyed a wide-ranging discussion and question and answer period with Senate Environment and Natural Resources Policy and Legacy Funding Committee Chair Sen. Carrie Rudd, and House Environment and Natural Resources Policy and Legacy Funding Committee Chair, Rep. John Persell. Together they covered aquatic invasive species, wakeboard boat impacts, the importance of healthy forests for water quality, and funding priorities.

Both legislators congratulated MLR members on the impact that their advocacy was having on educating legislators, and advancing the goals of clean and healthy lake and river ecosystems in Minnesota.

After a delicious walleye and wild rice dinner, MPR Chief Meteorologist Paul Huttner presented, "Changing Weather patterns and the Impacts on Our Lakes and Rivers." The data is sobering. Minnesota is experiencing the most rapid rise in average yearly temperature of any state in the lower 48, mostly due to warmer nights and winters. In addition, the data shows that Minnesota is also experiencing the most dramatic increase in our annual precipitation. Both of these facts will have significant impacts on our lakes moving forward, and require planning, adaptive management, and adaptation. Next, newly appointed DNR Commissioner Sarah Strommen shared with MLR members a goal she had for her time as DNR Commissioner. She laid out a compelling case for all conservation minded Minnesotans to get more kids outside learning about and enjoying our lakes, rivers and natural lands. She noted that people care about things they understand and have a connection with. Given falling hunting and fishing license sales among young people, finding new ways to engage young people with the outdoor world is critically important.

Commissioner Strommen also recognized that lake associations can play an important role in this effort. But Lake Associations often struggle to bring in younger members. There is tremendous opportunity for lake associations to partner with the MN DNR, school districts and local governments to develop programs and curriculum that will not only help develop the next generation of conservationists, but engage with their parents and the broader local community. ## West Nile Virus Impacting Minnesota Loon Population

A recent uptick in reports of dead loons and test results indicate an impact from West Nile virus (WNV), according to nongame wildlife staff at the Minnesota Department of Natural Resources.

The Veterinary Diagnostic Laboratory at the University of Minnesota confirmed WNV as the cause of death in two of three dead loons from northeastern Minnesota earlier this month. Wildlife staff are receiving a small but noticeable increase in calls from people finding dead loons in northeastern Minnesota this summer.

WNV was first confirmed in Minnesota in 2002 and was documented as a cause of loon mortality in Minnesota as early as 2005. It is not uncommon for people, animals and birds to be exposed to WNV through mosquito bites. Most people and animals successfully fight off the virus and develop antibodies against future infection. Some birds, like loons, crows and other corvids, are especially susceptible to the infection. Researchers are attempting to discover the rates of infection among ruffed grouse.

Loons can die from a variety of illnesses and injuries and individual bird deaths are a normal occurrence and not cause for alarm.

"Minnesotans love our loons and it's concerning for people to find them dead. When we start seeing multiple birds dying on a single lake, we want to know about it so we can start tracking the information and determine when further testing is warranted," said nongame wildlife specialist Gaea Crozier. "While there isn't a way to treat the West Nile virus infection, knowing the cause can help us rule out other, preventable causes of mortality."

Lake homeowners and other lake users who observe two or more dead loons on a single lake with no obvious injury or cause

of death are asked to email the nearest DNR nongame wildlife staff for tracking. For our area that would be Christine Herwig. Email christine.herwig@state.mn.us

Individual bird carcasses can be disposed of by burial or in the trash. There is no evidence people can contract WNV from infected birds, but gloves or a plastic bag are recommended when handling any dead animal. If reporting numbers reach a threshold that indicates a need for further testing, more information and handling protocols will follow.

The Minnesota Nongame Wildlife Program is funded almost entirely through grants and donations. More information about the DNR's Nongame Wildlife Program and the Loon Monitoring Program can be found on the DNR website at [mndnr.gov/nongame](http://mndnr.gov/nongame).

## Butterfly Tagging Demonstration

On Wednesday, August 24 from 10:00am-12:00pm there will be a Monarch Butterfly Tagging Demonstration Meet at the Prairie Hill trailhead at Glendalough State Park. All ages can learn how to catch and handle a monarch, determine whether it is male or female, and properly tag it. All monarchs will be released after they are tagged to continue their long migration to Mexico. Bring your own butterfly net if you have one, or share a park net if you don't. Long pants are recommended. Tagging will continue as long as there are enough tags and butterflies.

## DNR Seeks To Improve Sunfish Sizes

Large sunfish are scarce in many Minnesota lakes and local fisheries managers with the Minnesota Department of Natural Resources are responding to angler desire for bigger sunfish by seeking out specific lakes that would be a good fit for improving sunfish size quality by reducing sunfish bag limits.

Some angling groups have been asking the DNR for several years to consider modifying the 20-fish bag limit for sunfish and adding length restrictions, but angler survey data show apprehension over a statewide bag limit reduction or length restrictions. In response, the DNR is seeking to identify individual lakes that have the right biological characteristics, and local angler support, to benefit from reducing the sunfish bag limit.

"Sunfish grow slowly, about an inch per year. We could grow two trophy bucks in the time it takes to grow a trophy bluegill, but for decades we didn't think twice about keeping big sunfish," said Dave Weitzel, Grand Rapids area fisheries supervisor. "Now we're working locally to identify lakes capable of producing higher quality sunfish."

Starting this summer, fisheries managers will be meeting with local angling groups

to gauge support for reducing the sunfish bag limit on some lakes through the DNR's process of proposing special regulations. Angler input is an important part of that process — without support these regulation changes will most likely not go into effect.

Special regulations are specific to individual waters. Through the DNR's Quality Bluegill Initiative, fisheries managers aim to increase the number of special regulation lakes for sunfish from about 60 to between 200 and 250 lakes statewide by the year 2023.

"Just like anyone else, we want fishing for sunfish to be enjoyable and to a lot of folks that means catching a big sunfish. Without a management change, it's likely sunfish size will continue to decline, largely because of the influence we as anglers exert on their populations," Weitzel said.

On any lake, anglers can voluntarily help protect big sunfish by releasing or limiting their harvest of large sunfish, which are considered about eight inches or bigger.

Sunfish spawn in large nesting colonies during the spring and early summer. Parental male sunfish build and defend nests. Females will select a male, lay eggs, and leave the eggs for the male to protect and fan with his fins. These nest-building

male sunfish play an important role in repopulation, with the largest sunfish often getting the best spawning sites.

When anglers keep only the largest sunfish, the remaining small males don't need to compete with larger males to spawn.

Once the larger males are gone, the smaller males devote less energy to growing. Instead, they devote energy to spawning at younger ages and smaller sizes.

Spawning sunfish are particularly prone to over harvest because they are very aggressive while defending a nest. Anglers can help by releasing spawning sunfish, especially large, nesting males. Released fish have a high survival rate and will typically return to their nests to complete the spawning cycle.

## Let's Get Canning!

Canning is a treasured tradition that many people remember their mom or grandmother doing, but is a feat that many people don't feel they have the time or talent for. Here are some helpful tips to help you feel confident enough to start canning and stop wasting the veggies and fruits of your labor.

- Canning Jars-You must use jars specifically for canning. You cannot use any basic jar as they cannot endure the high temperatures or pressure of canning.
- A big heavy kettle to process the food before it is put in the jar.
- A large pot with a jar rack to process the jars once they are full.
- A lid lifter is needed to pull the lid out of hot water and put it on the jar without damaging the seal of the lid or burning your fingers.
- A set of tongs to lift the jar out of the boiling water.
- A pan to simmer the lids in to soften the sealant making them seal better.

Things to know:

- Make sure your recipe is current and tested.

- Thoroughly clean your work area, utensils and hands.
  - Jars should not be cracked or chipped. They should be sterilized in hot water for up to 10 minutes.
  - Lids should be new, but you can reuse your rings
  - Set aside enough time to complete your canning project as it can take several hours.
  - Cut/chop all foods to similar size so that they all heat at the same rate.
  - Water must be boiling before you can start your timer
  - There are so many different foods you can try canning with.
- Canning methods:
- Water bath Canning is typically used for high acid foods like jams, jellies, salsa, sauces or tomatoes.
  - Pressure Canning for low acid foods such as beef, poultry, pork, vegetables or venison.
- Always make sure that you read each recipe and process carefully. Keep the canning tradition Alive! Pass this tradition with your tips and recipes on to your family, friends and neighbors.

## Announcing Nine New Research Projects

Source: Minnesota Aquatic Invasive Species Research Center (MAISRC)

MAISRC is excited to announce nine new research projects that are launching this summer. These projects were selected as part of a competitive proposal process following a comprehensive research needs assessment. The results of these projects will improve our ability to detect, prevent, and manage aquatic invasive species throughout Minnesota. The projects include:

### Developing Carp Removal Schemes Using Social Learning Behaviors

This project will develop a new way to effectively remove invasive common carp from Minnesota lakes by selectively attracting them with food and removing them with specialized nets, while also taking into account their social behaviors. Led by Przemek Bajer.

### Historical Analyses Of Spiny Waterflea Invasion Patterns

Now that research has indicated that spiny waterflea have been in some Minnesota lakes much longer than originally thought, this project will test key hypotheses about the relationships between spiny waterflea invasion and the response to ecological, economical, and recreational services provided by Minnesota lakes. Led by Donn Branstrator.

### AIS Impacts On Walleye Populations And Mercury Concentrations

This project will assess the impacts of zebra mussels on walleye in Minnesota lakes, and will identify lakes that are most vulnerable to negative impacts based on recruitment, food web dynamics, and mercury concentrations. Led by Gretchen Hansen.

### Field Validation Of Multibeam Sonar Zebra Mussel Detection

This project will include field validation of laboratory results that test the utility of a swath mapping system -- multibeam sonar -- for detecting and quantifying the

presence and abundance of zebra mussels at large scales. Led by Jessica Kozarek.

### Impacts Of Invader Removal On Native Vegetation Recovery

This project will evaluate the ability of invasive aquatic plant control efforts to lead to recovery of native aquatic plant communities. Led by Dan Larkin.

### Genetics To Improve Hybrid And Eurasian Watermilfoil Management

This project will identify potentially problematic genotypes of hybrid watermilfoil and begin to test these genotypes for herbicidal response. Led by Ray Newman.

### Evaluating Innovative Coatings To Suppress Priority Ais

This project will test and develop a new coating that can be applied to equipment surfaces in order to decrease the spread of zebra mussels. Led by Mikael Elias.

### Will Property Values Cool As AIS Heat Up?

This project will evaluate the economic impacts of Eurasian watermilfoil on property values as well as quantify the role of water temperature and other lake characteristics in determining Eurasian watermilfoil abundance. Led by Gretchen Hansen.

### Evaluation Of Koi Herpesvirus For Use As A Potential Biocontrol Agent For Common Carp In Minnesota

After detecting koi herpesvirus in numerous mass mortalities of carp with no apparent effect on native species, this project will now evaluate its potential safety and efficacy as a biocontrol agent. Led by Nick Phelps.

## DNR Seeking Public Input On Cass Lake Fisheries Management Plan

Cass Lake – one of Minnesota’s 10 large walleye lakes – has a new draft management plan and the Department of Natural Resources is seeking input on it.

Cass Lake sunrise - The plan outlines the proposed five-year fish population objectives and fisheries management actions for Cass Lake and connected waters on the Cass Lake Chain. While the plan focuses on Cass Lake management, it is understood that fish populations, and anglers move throughout connected waters, and a management action on one basin affects the others.

The plan incorporates recommendations from a 14-member Cass Lake Fisheries Input Group, which included representatives from resorts, residents and lake associations on Cass Lake and connected waters, angling groups, species work groups, the Leech Lake Reservation Department of Resource Management, the Chippewa National Forest and the Cass Lake Area Chamber of Commerce.

“Fishing on the Cass Chain is very important to the communities of Cass Lake, Bemidji and the surrounding area,” said Gary Barnard, Bemidji area fisheries supervisor. “Minnesota’s large destination walleye fisheries like Cass Lake attract anglers from all across Minnesota and numerous other states.”

Members from the input group

provided important and diverse perspectives as users of the resource with a genuine interest in the long-term sustainability of the fishery. Input group members were concerned about the impact of angling pressure on the Cass Lake yellow perch fishery, and sunfish on connected waters, as anglers have become more mobile in targeting high quality populations.

The input group felt that the current status of the walleye and yellow perch fishery was excellent and encouraged the DNR to continue to support management efforts to sustain current levels of harvest.

The group also expressed concerns about system change and recommended that the DNR continue to study the potential impact of invasive species on the sustainability of the Cass Lake fishery.

The DNR is accepting public comments through Tuesday, Sept. 3, online at [mndnr.gov/casslake/index.html](http://mndnr.gov/casslake/index.html). Paper questionnaires also are available at the DNR’s Bemidji area fisheries office, 2114 Bemidji Ave. in Bemidji. Following a review of comments, the DNR will revise the draft and finalize the Cass Lake management plan in October.
