Board approved 750.00 if needed by group to complete study. County AIS may cover. Also spoke about getting a board member on COLA board.

Water Testing/COLA- June 1<sup>st</sup> readings-Ottertail is 20 ft. Blanch 13 ft., Round 14 ft., Deer 16 ft. Walker 7 ft., Long Lake 1 ft.

**Communications**-pictures and articles needed for LSN. Online membership is down on website. Bope will look into and make corrections. Bope discussed other updates to website being done. Wing talked about shoreline grant money. Info will be put on our website.

**Worm-**Worm spraying was discussed, had good participation across the lakes in the association and spraying was successful. Wentz discussed time and effort to do worm mailings and compiling data. Board voted to pay worm committee for time spent on duties related to worm mailings. Wentz discussed cost of spraying each lake vs what was collected by lake.
